Nous avons reporté les résultats sur un schéma afin de vous aider à faire des choix éclairés.

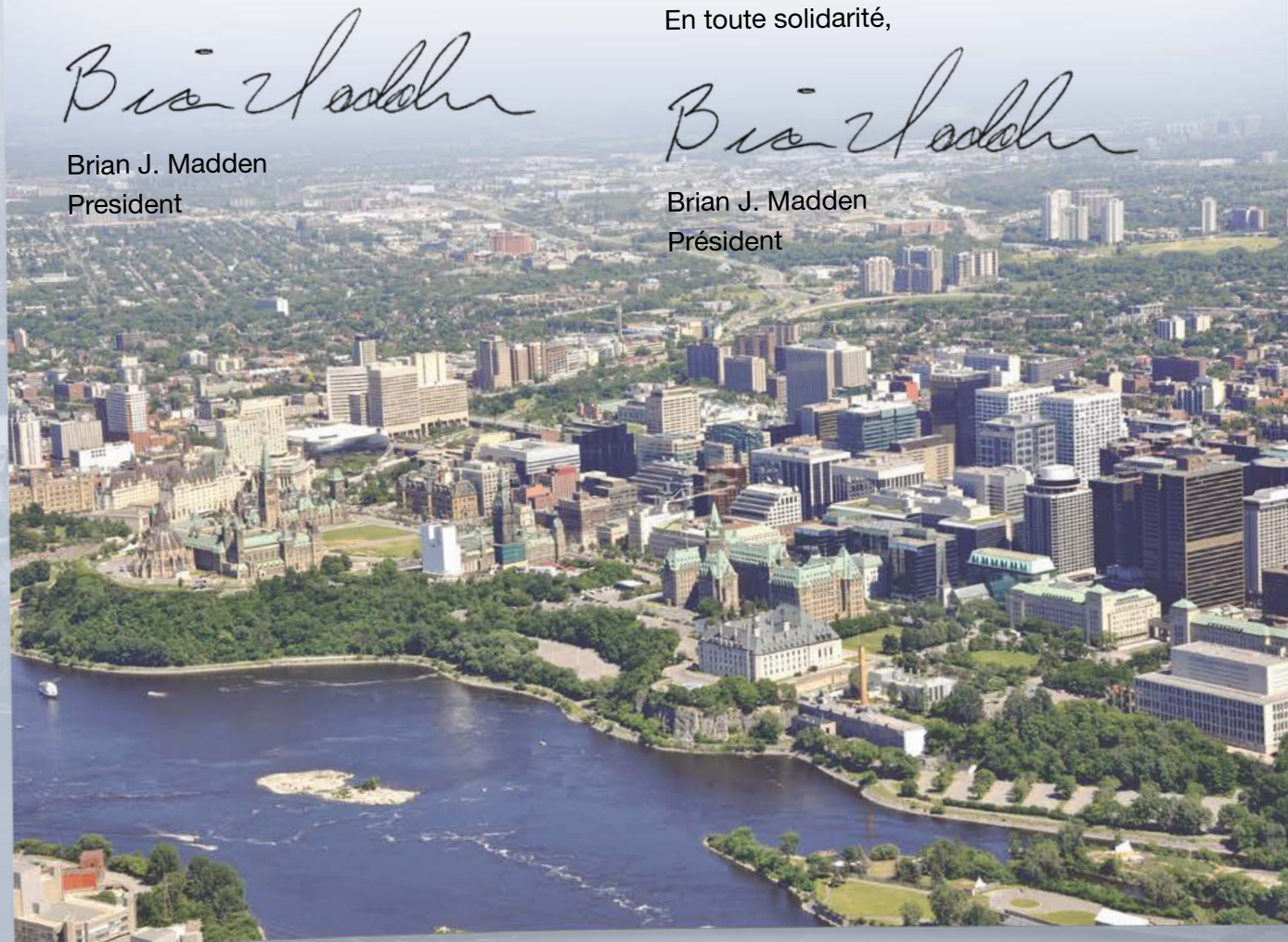
